### What is this product?

**Type** This product is a share in a sub-fund of the investment company with variable capital SMART VALUE INVESTORS, an undertaking for collective investment in transferable securities (UCITS) under Luxembourg law.

#### Term

This sub-fund has no maturity date. However, the board of directors of the fund may decide to close the sub-fund under certain circumstances.

#### **Objectives**

The objective of the sub-fund is to grow the capital invested above a balanced equity and bond portfolio in the long term while aiming to limit the impact of adverse shocks in equity and bond markets in the short term.

The sub-fund will invest its assets in a portfolio composed of equity assets, fixed income assets, time deposits and cash equivalents securities either directly or through investment funds.

The proportion of the sub-fund's assets invested in each type of asset class will vary from time to time upon general market and economic conditions.

However, the sub-fund exposure to the equity assets shall, at all-time, be limited to 75% of its Net Asset Value.

The investments in investment funds and/or investment funds traded on stock exchanges may not exceed 10% of the net assets of the subfund.

The equity assets in which the sub-fund may invest include interests in real estate investment trusts (REITs).

The sub-fund may also invest up to 25% of its net assets in exchangetraded commodities involving precious metals without physical delivery of the underlying metal.

For hedging or portfolio optimization purposes the sub-fund may use financial derivative instruments.

The investment manager integrates and promotes sustainability factors within his investment strategy by applying extra-financial data.

Benchmark: The portfolio is actively managed on a discretionary basis

without reference to a benchmark.

#### Intended retail investor

This product is designed for investors who are willing to achieve income and capital growth and have a medium to long term horizon. The investor can bear losses. This product is appropriate for investors with a basic to advanced knowledge and experience of the product and the markets.

#### Other information

Depositary: Banque de Luxembourg

Dividend income: This class is a capitalisation class meaning that income is reinvested.

Conversion right: The investor has the right to convert his investment in shares in one sub-fund for shares in the same sub-fund or in another sub-fund. The investor can obtain information about how to convert in the prospectus of the fund.
