What is this product?

Туре

This product is a share in a sub-fund of the investment company with variable capital SMART VALUE INVESTORS, an undertaking for collective investment in transferable securities (UCITS) under Luxembourg law.

Term

This sub-fund has no maturity date. However, the board of directors of the fund may decide to close the sub-fund under certain circumstances.

Objectives

The objective of the sub-fund is to grow the capital invested above global equity markets in the long term while aiming to limit the impact of adverse shocks in equity and bond markets in the short term.

The sub-fund will invest its assets in a portfolio composed of equity assets, fixed income assets, time deposits and cash equivalents securities either directly or through investment funds.

The proportion of the sub-fund's assets invested in Equity Assets will vary from time to time based upon the Investment Manager's assessment of risk/return opportunities with however a minimum of 51% of its net assets being invested in Equity Assets.

The investments in investment funds and/or investment funds traded on stock exchanges may not exceed 10% of the net assets of the subfund.

The equity assets in which the sub-fund may invest include interests in real estate investment trusts (REITs).

The sub-fund may also invest up to 25% of its net assets in exchangetraded commodities involving precious metals without physical delivery of the underlying metal.

For hedging or portfolio optimization purposes the sub-fund may use financial derivative instruments.

The investment manager integrates and promotes sustainability factors within his investment strategy by applying extra-financial data.

Benchmark: The portfolio is actively managed on a discretionary basis without reference to a benchmark.

Intended retail investor

This product is designed for investors who are willing to achieve income and capital growth and have a medium to long term horizon. The investor can bear losses. This product is appropriate for investors with a basic to advanced knowledge and experience of the product and the markets.

Other information

Depositary: Banque de Luxembourg

Dividend income: This class is a capitalisation class meaning that income is reinvested.

Conversion right: The investor has the right to convert his investment in shares in one sub-fund for shares in the same sub-fund or in another sub-fund. The investor can obtain information about how to convert in the prospectus of the fund.

To protect you, the assets are held with a separate company, the depositary Banque de Luxembourg. Should we default, the investments are liquidated and the proceeds are distributed to the investors. Recommended holding period: 8 years
